PROCEDURAL ORDER

BY THE COMMISSION:

On June 1, 2007, Unite Private Networks, LLC ("Applicant") submitted to the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide telecommunications services in the State of Arizona.

On June 29, 2007, and again on July 16, 2007, the Commission's Utilities Division Staff ("Staff") filed a Letter of Insufficiency and its First Set of Data Requests in this docket.

On August 13, 2007, Applicant filed its response to Staff's First Set of Data Requests.

To date, no other filings have been made in this docket. Accordingly, Staff should update the Commission on the status of this matter.

IT IS THEREFORE ORDERED that Staff shall file an update on the Applicant's application, along with any appropriate recommendations no later than ³⁰September 31, 2009.

IT IS FURTHER ORDERED that the Presiding Office may rescind, alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


