


JOINT STATUS UPDATE



15 Conference, Fidence Development, LLC ("Fidence Development") and Arizona-American
16 Water Company ("Arizona-American") provide this update regarding the status of
17 settlement discussions. Fidence and Arizona-American have continued to engage in
