

RE: IN THE MATTER OF THE APPLICATION OF VALLEY HOPE ASSOCIATION DBA CHANDLER VALLEY HOPE. FOR APPROVAL TO CANCEL A CERTIFICATE OF CONVENIENCE AND NECESSITY FOR CUSTOMER OWNED PAY TELEPHONE (DOCKET NO. T-02874A-09-0415)

On September 1, 2009, Valley Hope Association dba Chandler Valley Hope ("Chandler" or "Applicant") filed a request to cancel its Certificate of Convenience and Necessity ("CC&N") to provide customer owned pay telephone ("COPT") service. The Commission granted the Applicant a CC&N to provide COPT service in Decision No. 59199, dated August 8, 1995.

In the application, Ms. Jennifer Boller indicates that she is the authorized person to file the application and that Chandler no longer provides, or never did provide COPT service in the State of Arizona and requests cancellation of its CC&N. In the application, the Applicant did not waive her right to a hearing and did not waive her right to receive notice of a hearing in order to cancel the CC&N. However, Staff was able to contact the Ms. Boller via telephone on September 15, 2009. Ms. Boller indicated she is the authorized person to file the application and that she did not want to participate in a hearing in this matter.

The Compliance Section of the Utilities Division indicates that the Applicant does not have any outstanding compliance issues that need to be addressed with the Commission. The Applicant has not been entered into the compliance database.

The Consumer Services Section of the Utilities Division indicates no complaints, opinions or inquires have been filed against the Applicant. The Corporations Division reports Valley Hope Association is in Good Standing.

Staff recommends that the application to cancel the CC&N be approved. Upon cancellation of its CC&N, the Applicant will not be authorized to provide COPT telecommunications services in the state of Arizona and therefore, will not be subject to any of the requirements of Decision No. 59199.
