15 Having considered the entire record herein and being fully advised in the premises, the
16 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

17 **FINDINGS OF FACT**

18 1. Phonetel Technologies, Inc. ("Applicant") has a Certificate of Convenience and
19 Necessity ("Certificate") to provide customer-owned pay telephone ("COPT") service in the State of
20 Arizona pursuant to Decision No. 62021 (November 2, 1999).

21 2. On September 9, 2009, the Applicant filed with the Commission an application for
22 cancellation of the Certificate ("Application").

23 3. On September 23, 2009, the Commission's Utilities Division Staff ("Staff") filed a
24 Staff Report, recommending approval of the Application and cancellation of the Applicant's
25 Certificate without a hearing.

26 4. According to Staff, they contacted Donald Paliwoda, the Applicant's Chief Financial
27 Officer, and confirmed that he is authorized to submit the Application. Staff also verified that the
28 Applicant does not wish to have a hearing in order to cancel the Certificate.
