**ARIZONA CORPORATION COMMISSION
STAFF'S MOTION TO CONSOLIDATE
DOCKETS**

On July 17, 2009, the Estate of William F. Randall dba Valle Verde Water Company ("Valle Verde") filed a Finance Application for authority to incur debt to finance water system improvements. Valle Verde states in its Application that it is seeking to finance necessary improvements to its water production and distribution systems which will cost an estimated \$1,063,478.00. The Company states in its Application, that if the Commission authorizes the proposed debt, then the Water Infrastructure Finance Authority ("WIFA") will lend the Company \$1,063,478.00 for 20 to 30 years through the Drinking Water Revolving Fund.

On July 17, 2009, the Estate of William F. Randall dba Valle Verde Water Company also filed a Rate Application. Valle Verde states that certain of its wells are unusable due to contamination and high arsenic levels. Until recently, Valle Verde states it had to purchase water from the City of Nogales at a cost that exceeded what it could charge its customers, thereby causing it to incur substantial debt. The Company states that it also plans to make substantial system improvements. Valle Verde is seeking an increase in gross revenue of \$497,753 or a rate increase of approximately 109%.


