**MOTION FOR EXTENSION  
OF TIME**

F. Wayne & Dorothy Thompson dba West Village Water Company ("West Village" or "Company"), requests that the Arizona Corporation Commission ("ACC") staff deadline for filing the Staff Report be extended from June 15, 2009 to July 31, 2009.

The Company is making this request to give the Arizona Department of Environmental Quality ("ADEQ") system evaluator more time to offer his report. Although the Company requested the system evaluation several months ago, ADEQ did not assign the assessment until recently. Consequently, the evaluation is now underway, but not complete.

In this matter, the Company believes the engineer's system evaluation is crucial. The Company's position is that most of the water production and distribution facilities require significant capital improvements, but it has limited funds and debt capacity, so the Company must prioritize the proposed improvements. The ADEQ system evaluation will help the Company and others assess the Company's proposed capital improvement plans.
