PROCEDURAL ORDER

BY THE COMMISSION:

On February 11, 2005, Horizon Telecom, Inc. ("Company"), filed with the Arizona Corporation Commission ("Commission") its application for a certificate of convenience and necessity to provide resold long distance telecommunications services in Arizona ("Application").

On February 16, 2005, the Commission's Utilities Division Staff ("Staff") filed a Letter of Insufficiency and First Set of Data Requests.

On May 12, 2005, the Company filed its responses to the Data Requests.

On August 29, 2007, Staff filed its Second Set of Data Requests.

On October 9, 2007, the Company filed its responses to the Second Set of Data Requests.

On April 6, 2009, a Procedural Order was issued directing the Commission's Utilities Division Staff ("Staff") to file an update with the Commission on the status of this matter.

On April 28, 2009, the Company filed correspondence requesting that its Application be withdrawn. Staff has not objected to the request.

Accordingly, this docket should be administratively closed.

IT IS THEREFORE ORDERED that Horizon Telecom, Inc.'s, Application, Docket No. T-04306A-05-0091, is hereby administratively closed.


