PROCEDURAL ORDER

8 **BY THE COMMISSION:**

9 On January 11, 2001, the Arizona Corporation Commission ("Commission") issued Decision
10 No. 63315 in the above-captioned matter. As part of the Decision, the Commission ordered that
11 public comment be scheduled regarding the proposed rule amendments. Pursuant to those directions,
12 this Procedural Order establishes a hearing schedule.

19 July 5, 2001, companies or other interested persons are requested to file written comments on or
20 before June 21, 2001.

21 IT IS FURTHER ORDERED that, although comments in this matter will be taken through
22 July 5, 2001, companies or other persons (including the Utilities Division/Office of Pipeline Safety)
23 are requested to file written **reply** comments on or before June 28, 2001.


