" Hello Kristen. My name is Bambi Sandquist. I am a resident of Pinal County near Johnson Ranch. I am one of the women being sued by Mr. Johnson for speaking out about his Utility Company and the transgressions (spills/water violations) he has committed against his customers. For that he is charging me for defaming his character. A character that is public and he has managed to defame himself. Nonetheless, he is subjecting me to all this and it is wearing me out.

I stand on my first amendment rights of free speech. No malice was involved in my free speech. I am 65 and live on S.S. and I can take so much of this tyrant and his hooligans. I don't have representation as I can't afford an attorney. I can only be represented by the govt. if it is a criminal offense.
