
REQUEST FOR EXTENSION OF
DEADLINE PURSUANT TO
DECISION NO. 70983

In Decision 70983, the Commission ordered Curatel, LLC ("Curatel") to procure either a performance bond or an irrevocable sight draft letter of credit within 30 days of the effective date of the decision in this matter. Curatel has been actively pursuing a performance bond; however, due to some administrative delays with its bonding company, Curatel will not have a copy of the bond prior to the compliance deadline. Curatel will continue diligently to pursue the procurement of the bond and will submit it to the Commission as soon as it is received.

For the reasons set forth above, Curatel respectfully requests a 30-day extension of the deadline set forth in Decision No. 70983 to submit a performance bond or irrevocable sight draft letter of credit.
