PROCEDURAL ORDER

10 **BY THE COMMISSION:**

11 On December 14, 2007, CTC Communications Corp. ("CTC") and One Communications
 12 Corp. ("OCC") filed with the Arizona Corporation Commission ("Commission") an "Informational
 13 Filing Regarding a Pro Forma Change in Ownership of An Authorized Telecommunications
 14 Provider." In the filing, counsel for CTC and OCC stated that a transaction was to occur at the parent
 15 holding company level that would dilute the existing ultimate ownership of CTC, although OCC
 16 would remain the whole owner of CTC's stock, and CTC's stock would not be directly affected.

17 On April 22, 2009, a Procedural Order was issued requiring the Commission's Utilities
 18 Division Staff ("Staff") to file an update on the status of this matter, including any appropriate
 19 recommendations as to how the matter should be resolved and whether the matter should be
 20 administratively closed.

21 On May 20, 2009, Staff filed an update stating that the notice filed by CTC and OCC on
 22 December 14, 2007, did not require any action by the Commission and recommending that this
 23 matter be administratively closed.

24 Staff's recommendation is appropriate and should be followed.


