PROCEDURAL ORDER

BY THE COMMISSION:

On September 26, 2007, Broadview Networks Holdings, Inc. ("Broadview") and A.R.C. Networks, Inc. ("A.R.C.") filed with the Arizona Corporation Commission ("Commission") notice of a transaction that might result in the transfer of ownership control of Broadview and the indirect transfer of control of A.R.C., which holds a Certificate of Convenience and Necessity to provide telecommunications services in Arizona.

On April 22, 2009, a Procedural Order was issued requiring the Commission's Utilities Division Staff ("Staff") to file an update on the status of this matter, including any appropriate recommendations as to how this matter should be resolved and whether this matter should be administratively closed.

On May 8, 2009, Staff filed an update stating that the filing made by Broadview and A.R.C. on September 26, 2007, was a notification that does not require any action by the Commission and recommending that this matter be administratively closed.

Staff's recommendation is appropriate and should be followed.
