15 Undersigned counsel, pursuant to Rule 38 of the Rules of the Supreme Court of
16 Arizona, moves the Commission, for good cause shown, to temporarily admit Timothy P.
17 Burke as counsel *pro hac vice* in this action. Mr. Burke desires temporary admission *pro*
18 *hac vice* to appear on behalf of his client, Merrill Lynch, Pierce, Fenner & Smith,
19 Incorporated ("Merrill Lynch") at the open meeting before the Arizona Corporation

2 These application materials were submitted to the State Bar on June 8, 2009. Because the
3 open meeting at which the proposed consent order will be considered by the Commission
4 is set for June 11, 2009, counsel for Merrill Lynch respectfully request that Mr. Burke be
5 permitted to temporarily appear *pro hac vice*, pending completion of the application
6 process.




