BY THE COMMISSION:

On March 9, 2009, Diablo Village Water Company (“DVWC”) and Thim Utility Co. (“TUC,” and together with DVWC, “Applicants”), filed with the Arizona Corporation Commission (“Commission”) an application for approval to sell its assets and operations to Metropolitan Domestic Water Improvement District and to cancel the Applicants’ Certificates of Convenience and Necessity upon consummation of the sale.

On June 8, 2009, a Procedural Order was issued setting the matter for hearing. Page 2, lines 7 and 11 of the Procedural Order contain an incorrect reference to “QCWC.” The reference in on those lines should be to “DVWC.” All deadlines and requirements set forth in the Procedural Order remain the same.


