BSMC has filed this application to increase their monthly customer charge from the current \$45.64 to \$71.08. According to the monthly sewer charges published by the Arizona Republic on May 27, 2009, even the current BMSC monthly charge of \$45.64 is extremely high compared to these average customer city sewer monthly charges: Mesa \$24.23; Phoenix \$28.51; Scottsdale \$22.52; Glendale \$30.07; Peoria \$21.90; Gilbert \$24.28; Tempe \$17.34; & Chandler \$17.67. We request that the Arizona Corporation Commission deny this application for this monthly charge increase, and to instruct BMSC that they must reduce their current monthly customer charges to be more comparable to the local sewer company monthly charges.
