PROCEDURAL ORDER

BY THE COMMISSION:

On June 2, 2009, Antelope Run Water Company ("Antelope Run" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for the emergency implementation of a surcharge. The Company asserts it is in imminent danger of failing.

A Procedural Conference is necessary in order to determine a schedule for filing of the Staff Report and the Company's responses, if any, and the setting of a hearing date.

IT IS THEREFORE ORDERED that a telephonic Procedural Conference shall commence on June 26, 2009, at 9:30 a.m., immediately following the completion of the Procedural Conference in Docket No. W-01906A-09-0283, or as soon thereafter as is practical, and that the parties shall contact the Hearing Division on June 19, 2009, at 602-542-4250 for further information regarding the call-in phone number. IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized Communications) applies to this proceeding as the matter is now set for public hearing.




