PROCEDURAL ORDER

BY THE COMMISSION:

On August 5, 2008, Tel West Communications, LLC, ("Tel West" or "Company") filed with the Arizona Corporation Commission ("Commission") a notice indicating that it intended to cease providing telecommunication services in Arizona. The Commission's Utilities Division Staff ("Staff") subsequently informed the Company that it was required to file an application to abandon interexchange service pursuant to the terms of Arizona Administrative Code R-14-2-1107.

On May 19, 2009, the Company filed its application as required by Staff; however the application was assigned a new docket number, Docket No. T-03592A-09-0246, rather than being docketed in the existing docket, Docket No. T-03592A-08-0414.

On May 28, 2009, Staff filed a Memorandum recommending that the May 19, 2009, application be filed in Docket No. T-03592A-08-0414 and that Docket No. T-03592A-09-0246 be administratively closed, or alternatively that the matters be consolidated.


For ease of administration, the matters should be consolidated. The matters are substantially related and no party will be prejudiced by their consolidation.
