**COMPLIANCE TO A DECISION**

Decision No. 70658 requires Wilhoit Water Company report monthly revenue from its standpipe service on a quarterly basis.

Wilhoit deposited the revenue from the standpipe twice during March, April and May – once on March 30, 2009 (which was reported to the Commission in an April 8<sup>th</sup> filing) and again on April 14, 2009. The deposit on March 30<sup>th</sup> was \$3,000 and the deposit on April 14<sup>th</sup> was \$1,000 for a total \$4,000. The bank Wilhoit uses requires deposits in five hundred dollar increments.
