9 Pursuant to Rule 14-3-105, Arizona Administrative Code, Qwest
10 Corporation ("Qwest"), applies to the Arizona Corporation
11 Commission (the "Commission") for an order granting Qwest leave
12 to intervene in the above-captioned proceeding. The Commission
13 should grant Qwest leave to intervene in this matter because Qwest
14 is directly and substantially affected by these proceedings.

15 The Town of Wickenburg (the "Town") has requested that the
16 Town and the surrounding areas of Maricopa and Yavapai Counties be
17 included in the 623 area code and to be included in the side area
18 toll free calling area of the 623 area code. As the major
19 provider of telecommunication services in these areas, Qwest is
20 directly and substantially affected by the Town's request for an
21 implementation of extended area service ("EAS").

22 Qwest clearly has a substantial and direct interest in the
23 outcome of the Town's application. Further, Qwest's participation
24 in the proceeding will not unduly broaden the issues raised.


