PUBLIC NOTICE OF CHANGE
IN HEARING DATE
ON THE RATE APPLICATION OF
FARMERS WATER COMPANY
(DOCKET NO. W-01654A-08-0502)

Pursuant to the directive of the Arizona Corporation Commission, Farmer's Water Company mailed notice of the hearing on its application for an increase in rates to its customers on March 24, 2009. The need for additional time for Commission Staff to prepare its recommendations in this matter necessitates that the hearing be continued to a later date.

The Commission will hold a hearing on this matter beginning November 4, 2009 at 10:00 a.m. at the Commission's offices, Room 222, 400 West Congress St., Tucson, Arizona. The original hearing date of September 2, 2009, has been vacated.
