Staff has found a number of deficiencies with the rate application which are listed on a separate attachment. The 30-day sufficiency determination period will begin anew when the Company corrects the deficiencies and Docket Control receives an original and 15 copies of the corrected pages.

You have 15 calendar days, or until July 16, 2009 to correct the deficiencies, or make other arrangements with Staff to remedy your rate application.

The specific items that have caused a finding of deficiency are as follows:

1. On page 6 of the application, please state the Company's increase in a yearly amount, for example, \$252.60 (i.e. 12×21.05).
2. On page 6 of the application, please state what the Company's total annual operating revenues will be if the Company is granted the rate adjustment. For example, if the Company had \$2,839.30 in the test year, plus \$252.60 the total operating revenues would be \$3,091.90.
3. On page 9 of the application, the proposed rates are the same as the current rates. Please revise your rates to produce the total operating revenue you desire on page 6 of the application.
4. Once you fix the above, you will have to re-notify existing customers.
5. Please submit a new tariff, with the current rates approved in the Emergency Rate Case, Decision No. 70619 dated November 19, 2008.
6. Please provide a letter of good standing from the Arizona Department of Revenue.
7. On page 13 of the application (Plant Additions and Retirements by Year) you are missing years 1980 through 1997. If there were no addition or retirements for those years, please indicate if so, otherwise, please revise accordingly.
8. On page 13 of the application (Plant Additions and Retirements by Year) there are several numbers in the retirement column. Do these numbers represent when the Company plans to retire these assets or are these actual retirements for the year?
9. The bill counts do not produce the test year metered revenues or proposed metered revenues. Please reconcile.
10. Please provide Staff with a complete balance sheet. The Long-term debt amount on page 22 should be consistent with the amount listed on page 23.
11. On page 23, of the application, the Company lists 3 long-term loans. Please state the Arizona Corporation Commission Decision Number and date, in which these loans were approved. In addition, please fill out all parts of the form. For instance, the net proceeds, amount outstanding, date of maturity, and current year interest.

Other items:

1. Although this is not a deficiency item. On page 3 of the application, the Company states "Needs not listed yet required for plant operations. Ex pressure and storage tanks – pressure pumps – meters to measure well draw, security fencing. Need to secure financing." Does the Company intend to file a financing application along with this case?

2. Although this is not a deficiency item. On page 19 of the application, account 408.11 property taxes the Company stated that the property taxes are unpaid. Please provide Staff with a summary from the County of all back taxes owed.
