BY THE COMMISSION:

On April 17, 2009, Graham County Electric Cooperative, Inc. ("GCEC" or "Cooperative") filed with the Arizona Corporation Commission ("Commission") an application to approve the modification of its Certificate of Convenience and Necessity ("CC&N") and approve the transfer of the GCEC distribution facilities serving the Wal-Mart load to the City of Safford as described in greater detail in the Application.

On June 24, 2009, the Commission's Utilities Division ("Staff") filed a letter informing the Cooperative that its Application was sufficient.




