**MOTION FOR EXTENSION OF
TIME**

Access Point, Inc. ("API") respectfully requests that the due date for filing a bond or letter of credit in this docket be extended for 90 day. Decision No. 71118 (June 5, 2009) requires API to post a bond or letter of credit in the amount of \$125,000 within 30 days of the decision. API has contacted a number of insurance carriers and has not been able to find an insurer willing to issue a bond. API will be able to post a letter of credit. However, API is currently re-negotiating its line of credit with its lender. In addition, API's lender does not issue letters of credit, so API will have to work with its lender and a second financial institution in order to have a letter of credit issued. API believes that these issues can be resolved in the next 60-90 days. Thus, API respectfully requests that the deadline for submitting the bond or letter of credit be extended for 90 days.


