PROCEDURAL ORDER
GRANTING ADMISSION
PRO HAC VICE

BY THE COMMISSION:

On July 6, 2009, pursuant to Arizona Supreme Court Rule 38(a), Laura M. Kam, an attorney with DLA Piper LLP (US) filed with the Arizona Corporation Commission ("Commission") a Motion to Appear Pro Hac Vice for Joshua R. Pater of Milbank, Tweed, Hadley & McCloy LLP in the above-captioned matter, on behalf of the Respondent, RBC Capital Markets Corporation. 16 to appear at all hearings and procedural conferences, as well as all Open Meetings for which the
17 matter is scheduled for discussion, unless counsel has previously been granted permission to
18 withdraw by the Administrative Law Judge.
