**PROCEDURAL ORDER**

9 **BY THE COMMISSION:**

10 On March 29, 2006, Arizona Water Company (“AWC”) filed with the Arizona Corporation  
11 Commission (“Commission”) a Complaint in Docket Nos. W-01445A-06-0200, SW-20445A-06-  
12 0200, W-20446A-06-0200, W-03576A-06-0200, and SW-03575A-06-0200 (“Complaint  
13 Proceeding”) against Global Water Resources, LLC, Global Water Resources, Inc., Global Water  
14 Management, LLC, Santa Cruz Water Company, LLC, Palo Verde Utilities Company, LLC, Arizona  
15 Global Water – Santa Cruz Water Company and Arizona Global Water – Palo Verde Utilities  
16 Company (collectively “Global Water”).

17 Prior to and during the pending Complaint Proceeding, AWC and various Global Water  
18 entities filed applications with the Commission to extend their respective Certificates of Convenience  
19 and Necessity (“CC&Ns”) in Pinal County, including applications where the requested CC&N areas  
20 overlapped. The CC&N extension applications were filed in Docket Nos. W-03576A-07-0300, W-  
21 01445A-06-0199, SW-03575A-05-0926, W-03576A-05-0926, W-03576A-07-0300 and SW-03575A-  
22 07-0300 (“Contested CC&N Proceedings”).

23 Hearings regarding the above-captioned consolidated dockets were conducted on June 8 and  
24 9, 2009. At the conclusion of the hearing, AWC was directed to late file certain additional  
25 information in the form of an affidavit from one of its witnesses, Frederick Schneider. A briefing  
26 schedule was also established.

27 On June 12, 2009, AWC filed a request for an extension of time to file the affidavit of Mr.  
28

1 Schneider, until July 6, 2009.

2 By Procedural Order issued June 17, 2009, AWC's request for an extension of time was  
3 granted.

4 On July 6, 2009, AWC filed an additional request for an extension of time, until July 13,  
5 2009, to file the affidavit of Mr. Schneider. AWC again indicates that Global Water does not oppose  
6 the additional extension request, and that it does not believe Staff would oppose the extension  
7 although AWC had been unable to contact Staff counsel.

8 IT IS THEREFORE ORDERED that **Arizona Water Company's request for an additional**  
9 **extension of time to file the affidavit of Frederick Schneider is granted. Arizona Water**  
10 **Company shall file the affidavit by no later than July 13, 2009.**

11 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend or  
12 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at  
13 hearing.
