**COMPLIANCE TO A DECISION**

In the Commission's Decision, Wilhoit was ordered to monitor the Yavapai System and submit the gallons pumped and sold to determine the actual water loss for one full year.

Since the Decision, due to excessive arsenic present in its wells, the Company has relied on an interconnect with the City of Prescott to supply water to its customers. Since the Company has not pumped any water, it is unable to report on the any water loss experienced by the system.
