THIRD
PROCEDURAL ORDER

BY THE COMMISSION:

On April 24, 2009, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Team Heat, L.L.C. ("THL") and Thomas S. Blackwell and Kimberly Blackwell, husband and wife, (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts.

The Respondents were duly served with a copy of the Notice.

On May 20, 2009, a request for hearing was filed by the Blackwell Respondents.

On May 21, 2009, by Procedural Order, a pre-hearing conference was scheduled on June 29, 2009.

On June 15, 2009, counsel for Respondents filed a Motion for a Continuance of the pre-hearing conference due to a conflict with a previously scheduled matter in Coconino County.

On June 16, 2009, by Procedural Order, the proceeding was continued to July 23, 2009.


On July 23, 2009, the Division appeared with counsel and counsel for Respondent failed to

1 appear. It was subsequently learned that Respondents' counsel had not received notice of the
2 continuance due to an error in address of Respondents' counsel.

3 Accordingly, the pre-hearing conference should be continued.

4 IT IS THEREFORE ORDERED that the **pre-hearing conference** scheduled on
5 July 23, 2009, shall be **continued to August 18, 2009, at 10:00 a.m.**, at the Commission's office,
