NOTIFICATION OF  
INTERVENTION

BY THE COMMISSION:

On July 10, 2009, Freeport-McMoRan Sierrita Inc. ("Freeport-McMoRan") and Arizonans for Electric Choice and Competition ("AECC") filed with the Arizona Corporation Commission ("Commission") an Application to Intervene in the above-captioned matter.

Freeport-McMoRan states that it maintains facilities and operations in Arizona which use a significant amount of electric power from Tucson Electric Power Company ("TEP"). AECC is a coalition of energy consumers, most of whom use large amounts of power from TEP. Both entities state they, or their members, will be directly and substantively affected by the decision of the Commission in this matter.

No party objected to the request to intervene.

IT IS THEREFORE ORDERED that the request to intervene by Freeport-McMoRan and AECC is hereby granted.


