

PUBLIC NOTICE OF AN APPLICATION FOR AN ORDER TO AUTHORIZE THE ISSUANCE OF DEBT BY ESTATE OF WILLIAM F. RANDALL D.B.A. VALLE VERDE WATER COMPANY.

VALLE VERDE WATER COMPANY, (APPLICANT) HAS FILED AN APPLICATION WITH THE ARIZONA CORPORATION COMMISSION (COMMISSION) FOR AN ORDER AUTHORIZING THE APPLICANT TO RECORD FINANCING APPROVAL. THE PRESENT RATES HAVE BEEN IN EFFECT SINCE 04/01/96. THE AMOUNT OF FINANCING WILL BE FOR \$ 1,063,478. THE APPLICANT HAS HAD TO BORROW MONEY FOR WATER LINE REPLACEMENT AND UPGRADE, WELL INTERCONNECTION, INSTALL ARSENIC TREATMENT SYSTEM, ABANDON CONTAMINATED WELLS, RELOCATE WATER MAINS AS WELL AS MAP THE WATER SYSTEM.

THE APPLICATION IS AVAILABLE FOR INSPECTION DURING REGULAR BUSINESS HOURS AT THE OFFICE OF THE COMMISSION IN TUCSON, ARIZONA, 400 W. CONGRESS, ROOM 218, 85701 AND APPLICANT'S OFFICE AT, 2102 N. Forbes Blvd., Ste 107, Tucson, AZ 85745.

INTERVENTION IN THE COMMISSION'S PROCEEDING ON THE APPLICATION SHALL BE PERMITTED TO ANY PERSON ENTITLED BY LAW TO INTERVENE AND HAVING A DIRECT SUBSTANTIAL INTEREST IN THE MATTER. PERSONS DESIRING TO INTERVENE MUST FILE A MOTION TO INTERVENE WITH THE COMMISSION WHICH MUST BE SERVED UPON APPLICANT AND WHICH, AT A MINIMUM, SHALL CONTAIN THE FOLLOWING INFORMATION:

- 1) NAME, ADDRESS AND TELEPHONE OF THE PROPOSED INTERVENER AND OF ANY PERSON UPON WHOM SERVICE OF DOCUMENTS IS TO BE MADE IF DIFFERENT THAN THE INTERVENER.
- 2) A SHORT STATEMENT OF THE PROPOSED INTERVENER'S INTEREST IN THE PROCEEDING.
- 3) WHETHER THE PROPOSED INTERVENER DESIRES A FORMAL EVIDENTIARY HEARING ON THE APPLICATION AND THE REASON FOR SUCH A HEARING.
- 4) A STATEMENT CERTIFYING THAT A COPY OF THE MOTION TO INTERVENE HAS BEEN MAILED TO THE APPLICANT.

THE GRANTING OF MOTIONS TO INTERVENE SHALL BE GOVERNED BY A.A.C. R14-3-105, EXPECT THAT ALL MOTIONS TO INTERVENE MUST BE FILED ON, OR BEFORE, THE 15TH DAY AFTER THIS NOTICE.
