Dear Sir or Madam:

This letter is being filed in compliance with Decision No. 68447 in the above referenced docket, which requires Qwest to file a notice with Docket Control on the same date as the filings required by Findings of Fact No. 26, as modified by Findings of Fact No. 73. Qwest has provided the following reports required by Decision No 68447 to the Commission's Compliance office.

Finding of Fact # 26

Requirement 8.a.1 – Provided to Compliance office on 7/31/09.

QCC Total Accounts in Service categorized by NPA are to be provided. The information shall be provided in excel file format using electronic media.

Requirement 8.a.2 – Provided to Compliance office on 7/31/09.

QCC Total Lines in Service categorized by NPA are to be provided. The information shall be provided in excel file format using electronic media.

Requirement 8.b.4 – Provided to Compliance office on 7/31/09.

State-wide summarized Listings Data should be provided. The information should contain all main listings and additional line listings by Qwest Corporation, QCC, CLECs, ILECs, Wireless Providers or Other for each NPA-NXX level; no end-user specific information should be provided. The information shall be provided in excel file format using electronic media.

Requirement 8.b.5 – Staff now has access to this data directly from Telcordia. Pursuant to an agreement with Staff, Qwest need only confirm that Staff continues to have access

to the Telcordia database and file a letter to that effect in lieu of the report. Qwest's letter was provided to the Compliance office on 7/31/09.

State-wide summarized local exchange routing guide ("LERG") information should be provided. The report should contain the following column headings and be provided in excel file format using electronic media:

- a. All Switch common language location identification ("CLLI") codes.
- b. All Switch Locations (addresses)
- c. All Switch Owner Names
- d. All Switch Owner IDs
- e. All NPA, NXXs, or thousands blocks where NPA NXXs are shared, assigned to each switch
- f. All owner names corresponding to each NPA NXXs, or thousands block where NPA NXXs are shared.

Finding of Fact # 73

Requirement 1 – QCC still has no customers utilizing local exchange service. Therefore, Staff has agreed that the QC Customer Disconnect Report required under Finding of Fact # 73.1 need not be filed at this time, given that its intended purpose was to track movement of customers between QC and QCC.

Qwest Corporation shall provide the following information pertaining to Enterprise Customers to Staff every six months for three years which information shall be disaggregated on a monthly basis:

Number of Disconnects

Including the customer name and the number of switched access lines by wire center.

Requirement 2 – Provided to Compliance office on 7/31/09.

QCC shall provide the following information to Staff every six months for three years which information shall be disaggregated on a monthly basis:

Number of new Connections

Including name of customer and number of switched access lines by wire center.

QCC shall also provide its aggregate revenues derived from regulated local exchange services in its report to Staff which is filed every six months.

Finding of Fact 26.8 provided that the requirement to file the above reports would expire 3 years "following approval of QCC's CLEC operations." QCC's application was granted on February 2, 2002 and this report covers the final 6 months of the required reporting period. As such, no further reports are required in connection with Decision No. 68447 nor will any future reports be filed in connection with this matter.
