Supplemental Responses to Requests for Admissions

- A. Admit or Deny: The company engaged in activities referred to as “wash,” “round trip” or “sell/buyback” trading. This trading involves the sale of natural gas together with a simultaneous purchase of the same product at the same price.

RESPONSE: In its initial response submitted June 5, 2002 in this docket, Reliant¹ informed the Commission that none of its volume-building “roundtrip” trades were transacted in the WSCC in 2000-2001. Reliant also described to the Commission the small number of trades (approximately 15 pairs) that were identified as having some characteristics of roundtrip trades, but arose under distinguishable circumstances (*i.e.*, trades with terms that matched coincidentally or were conducted for legitimate business purposes). To further the Commission Staff’s investigation, Reliant is supplementing its June 5, 2002 response by providing transaction information relative to these same-day, non-roundtrip transactions. This supplemental spreadsheet identifies the previously referenced non-roundtrip trades and contains a key describing the characteristics that distinguish the listed transactions from roundtrip trades.

¹ This response is provided on behalf of Reliant Energy Services, Inc. (“RES”), Reliant Energy Resources Corp., and Reliant Energy Power Generation, Inc., the affiliates of Reliant Energy Incorporated (“REI”) and Reliant Resources, Inc. (“RRP”) that sell natural gas and trade in markets within the U.S. portion of the Western Systems Coordinating Council (“WSCC”) and Texas (collectively, “Reliant”).







The scope of this request encompasses all material that address or discuss your company's knowledge or awareness of *other companies'* use of the trading strategies discussed in the Enron memoranda, or similar trading strategies, including, but not limited to: (i) offers by such other companies to join in transactions related to such trading strategies, regardless of whether such offers were declined or accepted; and (ii) possible responses by your companies to other companies' use of such trading strategies. To the extent that you wish to make a claim of privilege with respect to any responsive material, please provide an index of each of those materials, which includes the date of the each individual document, its title, its recipient(s) and its sender(s), a summary of the contents of the document, and the basis of the claim of privilege.

RESPONSE:

As part of its submission to this Commission on May 22, 2002, Reliant produced a copy of a 44-page slide presentation prepared by Perot Systems Corporation. On June 7, 2002, Reliant submitted a Supplemental Response relating to this document. In its Supplemental Response, Reliant informed the Commission Staff of a workshop Perot Systems conducted for Reliant's West power traders in June 1998. At the time of filing of the Supplemental Response, Reliant had not located any written information about the content of the June 1998 workshop, but believed it to be unrelated to the document included in Reliant's May 22 Response. Since that time, Perot Systems has located and provided to Reliant, and posted on the Perot Systems' company website, the document Perot Systems believes was presented at the June 1998 workshop. While Reliant cannot independently verify the authenticity of this document, Reliant has no reason to believe Perot Systems' identification to be incorrect. Based upon review of the June 1998 document, Reliant has confirmed its previously held belief that the document that Reliant provided with its May 22 Response is not related to the June 1998 workshop. Reliant is supplementing its response in this docket to submit a copy of the June 1998 presentation identified by Perot Systems. It is Reliant's understanding that this presentation has been provided by Perot Systems to the California Senate's Select Committee chaired by Senator Joseph Dunn.




