1 ALJ STERN: This prehearing conference is now
2 open in the matter of Thomas Blackwell, et al., in
3 Docket Number S-20673A-09-0198. My name is Marc Stern.
4 I will preside over this proceeding today.

5 We will take appearances. And on behalf of
6 Securities Division?

7 MR. LUDWIG: Aaron Ludwig.

8 ALJ STERN: All right. And on behalf of
9 respondents, I will note for the record, apparently, we
10 had a miscommunication with counsel for the respondents,
11 in this proceeding Mr. Kevin Jensen. He requested a
12 hearing for the respondents, and he also -- subsequently
13 to a prehearing conference being scheduled, previously
14 he requested the matter be continued, and we rescheduled
15 this matter for today. And unfortunately, as I learned
16 moments ago, the address which we were using for the
17 respondents' counsel is an address that is over a year
18 old. It is partially our fault, I believe, and
19 partially respondents' counsel, because his letterhead
20 has an old address on it.

21 I spoke with the secretary for Mr. Jensen. He
22 is out of town on vacation unfortunately, and I informed
23 her that we would reschedule the matter because of the
24 addressing problem, or the address problem, and she
25 informed me that he won't be back until the end of the

1 month and then has a trial that is starting for at least
2 a week. So she suggested possibly the third week in
3 August. That is no problem, is it, Mr. Ludwig?

4 MR. LUDWIG: No, it is not.

5 ALJ STERN: Okay. And in the meantime, I also
6 suggested that they contact you.

7 Anything else from the Division, sir?

8 MR. LUDWIG: The only thing I would like to
9 bring to your attention is the fact that an answer has
10 not been filed. I don't know if the procedural order
11 could require an answer be filed, but I just thought I
12 would bring that to your attention.

13 ALJ STERN: Okay. With that, we will put out
14 an order rescheduling this matter. I will also direct
15 the respondents' counsel to file an answer in the
16 proceeding.

17 And anything else?

18 MR. LUDWIG: Nope, nothing further.

19 ALJ STERN: Okay. That will conclude this
20 matter at this time. Thank you.

21 MR. LUDWIG: Thank you.


