**STAFF'S MOTION TO SUSPEND
THE TIME CLOCK**

Staff of the Arizona Corporation Commission ("Staff") requests a 90-day suspension of the time clock in this matter. Pineview Water Company, Inc. ("Company") is a Class C Utility. The Company filed its rate application on July 18, 2008 indicating an April 1, 2007 through March 31, 2008 test year. Staff found the Company's application sufficient April 23, 2009.

Since sufficiency, the Company has experienced difficulty in providing Staff with an accurate bill count, for the test year, due to glitches in its billing program. However in the mean time, the Company has implemented a new billing program that it believes has resolved this problem. In light of this new billing program, the Company would like to change the test year to January 1, 2008 through December 31, 2008. Changing the test year will allow the Company to provide bill count information using only the new billing program. Staff does not oppose this change.

However, the Company will need additional time to provide this information, and Staff will need additional time to process this information. Wherefore, Staff respectfully requests an extension of the time clock in this matter by an additional 90 days, that the Administrative Law Judge vacate the hearing currently set for November 2, 2009, and modify the procedural schedule in this matter accordingly. Staff has contacted Mr. McDonald, and he does not oppose this extension.
