





Dear Customer:

LDMI, Inc. which does business under the name of its parent company, Cavalier Telephone, has filed an application with the Arizona Corporation Commission to discontinue providing long distance telecommunications services in Arizona. Effective October 1, 2009, LDMI will no longer provide the long distance telecommunications services you currently receive at the above location.

You may continue your long distance service at the same rates, terms and conditions with another Cavalier affiliate, Talk America, Inc. Talk America also does business also as Cavalier Telephone in Arizona, and should you choose Talk America's service, the Cavalier name on your bill will not change, and your rates will remain the same. However, in order to have service with Talk America d/b/a Cavalier Telephone, it will be necessary for you to complete and return the attached Letter of Authorization prior to October 1, 2009.

You also have the option of selecting any other certified provider of long distance service in Arizona. Should you choose to select another provider, please do so prior to October 1, 2009 in order to avoid any interruption in your ability to make long distance calls.

Enclosed is a stamped self-addressed envelope for return of the Letter of Authorization if you elect to remain with Cavalier.
