RUCO'S APPLICATION TO INTERVENE

1 I.

2 The RESIDENTIAL UTILITY CONSUMER OFFICE ("RUCO") hereby applies to the
3 Arizona Corporation Commission ("Commission") for an Order granting it leave to
4 intervene in the above-captioned proceeding.

5 II.

6 RUCO was established by the enactment of Arizona Revised Statutes, Section 40-
7 461, *et seq.*, for the purpose of representing residential utility consumers in matters before
8 the Commission concerning regulated public service corporations.

9 III.

10 Arizona Revised Statutes, Section 40-464.A.2., specifically provides that the
11 Director of RUCO may do the following:

14 Prepare and present briefs, arguments, proposed rates or
15 orders and intervene or appear on behalf of residential utility
16 consumers before hearing officers and the Corporation
17 Commission as a party in interest and also participate as a
18 party in interest pursuant to Section 40-254 in proceedings
19 relating to rate making or rate design and involving public
20 service corporations.

21 IV.

22 The residential utility consumers will be directly and substantially affected by a
23 Decision or Order of the Commission in this matter, therefore, it is necessary and proper
24 that RUCO intervene in the proceeding.




