SECOND  
PROCEDURAL ORDER

**BY THE COMMISSION:**

On April 22, 2009, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Lamont C. Patterson II and Eletrea L. Patterson, husband and wife, and Olof Enterprises, L.L.C. ("OEL") (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts and/or commodity investment contracts.

The Respondents were duly served with copies of the Notice.

On July 23, 2009, a request for hearing was filed by the Respondents.

On August 6, 2009, by Procedural Order, a pre-hearing conference was scheduled on August 27, 2009.

On August 27, 2009, at the pre-hearing conference, the Division appeared with counsel and the Respondents did not appear. Counsel for the Division indicated that he had been contacted by the Respondents and they were attempting to reach a resolution of the issues raised in the Notice by entering into a Consent Order which would be submitted for Commission approval at the

1 October 8, 2009, Open Meeting. The Division requested that a status conference be scheduled in  
2 approximately 30 days to review the status of the proceeding and whether the Consent Order would  
3 be included on Commission's agenda at its October 8, 2009, Open Meeting.

4 Accordingly, a status conference should be scheduled.

5 IT IS THEREFORE ORDERED that a **status conference** shall be held on **September 24,**  
6 **2009, at 10:30 a.m.,** at the Commission's offices, 1200 West Washington Street, Room 100,  
7 Phoenix, Arizona.
