PROCEDURAL ORDER
NUNC PRO TUNC TO
CORRECT DECISION NO. 70384

BY THE COMMISSION:

On June 13, 2008, the Arizona Corporation Commission ("Commission") issued Decision No. 70384 in the above-captioned matters.

On August 27, 2009, the Commission's Utilities Division ("Staff") filed a Motion for a Procedural Order *Nunc Pro Tunc* to be issued to correct a typographical error in the Decision. Staff states that in the Findings of Fact section of the Decision at Page 6, line 23, the Decision references the Service Line Charge for a 6" Meter, showing a charge of "\$1,730.00." However, in the Order section of the Decision, at Page 14, line 23, the same Service Line Charge for a 6" Meter is shown as "\$1,173.00." It is apparent that the amount appearing in the Order section is a typographical error and that the correct Service Line Charge should be \$1,730.00.

Accordingly, a *Nunc Pro Tunc* Procedural Order should be issued and Decision No. 70384 modified to correct the typographical error.
