REPORT**


13 On July 17, 2009, by a Procedural Order, the Commission's Utilities Division ("Staff") was  
14 directed to file a Staff Report in this matter within 60 days of receiving West Village Water  
15 Company's ("Company") notification that the Arizona Department of Environmental Quality  
16 ("ADEQ") has completed its evaluation of the Company's water system. On August 13, 2009, the  
17 Company filed its ADEQ Water System Evaluation Report ("Report").

18 Staff has reviewed this Report, but is unable to match the Report's recommended  
19 improvements with the financing request in this matter. Therefore, Staff finds this Report incomplete  
20 with regard to which improvements are to be considered in the financing request. Staff contacted the  
21 Company's counsel and consultant on August 18, 2009 requesting a cost breakdown for each  
22 improvement per the financing request. As of this date, the Company has not responded to Staff's  
23 request.

24 Because the submitted Report did not identify and support the financing request, Staff is  
25 unable to adequately analyze the Company's financing request. For this reason, Staff hereby requests  
26 that it be provided sixty (60) days from the date the Company provides Staff with the requested  
27 supporting information.
