BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. Beals Pay Phones, L.L.C. ("Applicant") has a Certificate of Convenience and Necessity ("Certificate") to provide customer-owned pay telephone ("COPT") service in the State of Arizona pursuant to Decision No. 60482 (November 25, 1997).

2. On September 11, 2008, the Applicant filed with the Commission an application for cancellation of the Certificate ("Application").

3. On August 27, 2009, the Commission's Utilities Division Staff ("Staff") filed a Staff Report, recommending approval of the Application and cancellation of the Applicant's Certificate without a hearing.




4. According to Staff, on July 20, 2009, Staff contacted Gary Beals, the company's owner, and confirmed that he is authorized to submit the Application. Staff also verified that the Applicant does not wish to have a hearing in order to cancel the Certificate.

ORDER

IT IS THEREFORE ORDERED that the Application of Beals Pay Phones, L.L.C., for the cancellation of the Certificate of Convenience and Necessity to provide customer-owned pay telephone service shall be, and is hereby, approved.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
