PROCEDURAL ORDER

**BY THE COMMISSION:**

On October 29, 1999, Carrington Estate Planning Services, *et al.* ("Carrington") filed a "Motion for Order Quashing Securities Division's Subpoena and Terminating Its Investigation ("Motion") in the above-captioned matter.

On November 17, 1999, the Securities Division ("Division") of the Arizona Corporation Commission filed its Response to Carrington's Motion requesting that the Motion be denied and that Carrington be ordered to comply by a date certain.


