**PROCEDURAL ORDER**

**BY THE COMMISSION:**

On June 1, 2000, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order for Relief ("Notice") against Successful Finance, Inc. ("SFI"), and Mary Kersey, (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of promissory notes or investment contracts.

The Respondents were all duly served with copies of the Notice.

On June 13, 2000, Respondents SFI and Ms. Kersey filed a request for hearing.

Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the Notice and the presentation of evidence.

IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on June 29, 2000, at 10:30 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.


