**APPLICATION OF SOLARCITY

Pursuant to A.A.C. R14-3-105, SolarCity hereby applies to the Arizona Corporation Commission (the "Commission") for an Order granting SolarCity leave to intervene in the above-captioned proceeding.

SolarCity is the nation's leading full-service solar provider for homeowners, businesses and government organizations. SolarCity provides solar power system design, financing, installation and monitoring services from a single source. Accordingly, SolarCity will be directly and substantially affected by the Commission's decision in this matter. Specifically SolarCity will be directly affected by the Commission's decision regarding APS's request to re-allocate up to \$20 million in residential solar incentives to apply to school projects and to be paid as an up-front incentive. SolarCity currently has

1 two large school projects under contract and the Commission's decision in this docket
2 will likely determine whether these projects get funded and built in 2009. SolarCity's
3 participation in this proceeding will neither broaden the issues nor delay the proceeding.
4 Therefore, SolarCity respectfully requests that the Commission grant this Application for
5 Leave to Intervene in this matter.
