
On July 15, 2009, the Securities Division filed a Motion to Amend its Notice to add a new party, Rodney Peterson, as well as new facts. On July 30, 2009, counsel for Respondents Giuffrida and Energetics filed a Notice indicating they did not object to the Securities Division's Motion. On July 30, 2009, by Procedural Order, Judge Stern ordered the Securities Division's Motion granted.

The Securities Division has not personally served Respondent Rodney Peterson. Therefore, the Securities Division intends to serve Rodney Peterson by publication. Pursuant to A.C.C. R14-4-303(H), the Securities Division will need at least four weeks to publish the Notice on Respondent Rodney Peterson as well as an additional 30 days to allow Respondent Rodney Peterson to respond to the Securities Division's Notice. Because of the time required to serve Respondent Rodney Peterson by publication, not all of the parties will have been served by the date of the hearing.

1 Therefore, the parties jointly agree and stipulate to vacate the witness list and exhibits
2 exchange due on September 14, 2009 and to vacate the hearing date scheduled for October 13,
3 2009. The parties would request that a status conference be scheduled after November 9, 2009 to
4 allow the Securities Division time to serve Respondent Rodney Peterson by publication and to
5 schedule another hearing date that would include all parties.


