RE: **ADMINISTRATIVE CLOSURE** - IN THE MATTER OF THE APPLICATION OF STAR IMPEX LLC FOR APPROVAL OF A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE PUBLIC PAY TELEPHONE SERVICE IN THE STATE OF ARIZONA (DOCKET NO. T-20546A-07-0473)

On August 14, 2007, Star Impex LLC ("Star") filed an application for a Certificate of Convenience and Necessity ("CC&N") to provide customer owned pay telephone ("COPT") services in Arizona. On August 27, 2007, the Commission's Utilities Division ("Staff") deemed Star's Application to be insufficient and sent Staff's First Set of Data Requests to Star. Staff's First Set of Data Requests was returned to Staff unopened and marked "Returned to Sender, Unclaimed, Unable to Forward."

On July 30, 2009, Staff contacted Yash Mehta, Manager, of Star Impex LLC. A copy of Star's Application and Staff's First Set of Data Requests was faxed as requested to Mr. Mehta. Also, Staff e-mailed a copy of the Star's Application and Staff's First Set of Data Requests as requested to Mr. Mehta on July 31, 2009. In the e-mail, Staff requested that Mr. Mehta inform Staff whether he wished to pursue this Application.

On August 3, 2009, Mr. Mehta sent an e-mail to inform Staff that he does not want to pursue this Application. Staff does not object to Star's request to withdraw its Application. Staff recommends that this docket be administratively closed.
