
The Securities Division ("Division") does not object to Respondent Tanzania Reynolds' request for a continuance of the pre-hearing conference scheduled for September 15, 2009. However, the Division objects to Respondent Tanzania Reynolds' request for a 60-day continuance.

The Division believes a 30-day continuance is sufficient as Respondent Tanzania Reynolds has had more than a month to locate counsel. Respondent Tanzania Reynolds was served with the Division's Notice on July 31, 2009 by certified mail. On August 13, 2009, Respondent Tanzania Reynolds filed a request for a hearing. On August 18, 2009, the pre-hearing conference, through a Procedural Order, was ordered to be held on September 15, 2009.

1 Therefore, Division does not object to the continuance; however, the Securities Division


