BY THE COMMISSION:

On July 1, 2009, Arizona Public Service Company ("APS" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for approval of its 2010 renewable energy standard implementation plan and distributed energy administrative plan and request for reset of renewable energy adjustor.

On September 4, 2009, Freeport-McMoRan Copper & Gold, Inc. ("Freeport-McMoRan") and Arizonans for Electric Choice and Competition ("AECC") filed an Application to Intervene.

To date, no objections have been filed and accordingly, Freeport-McMoRan and AECC's Application to Intervene should be granted.


IT IS THEREFORE ORDERED that Freeport-McMoRan and AECC are hereby granted intervention.


