20 a. The Sun Watts Large-Scale Generating Program being funded with REST funds.  
21  
22 b. Fair distribution of the 2010 REST budget and the reduction of Rebate being reduced  
23 from \$4.00 to \$3.00.  
24  
25 c. Proposed credit in subsequent billing period for excess kWh generated to be applied  
26 to the same on or off peak.  
27  
28 d. Schedule to recover Average Avoided Cost for customers with NET Metering.  
29  
30 e. The use of September 1st to zero balance customer's excess generating credits.  
31  
32 f. Company web site stating it does not allow renewable energy systems with battery or  
33 generator backup.

35 g. 2010 plan does not meet Annual Energy Requirements for obtaining Renewable  
energy credits.


1 h. Company's lack of REST funds for applications received in 2009.
