**JOINT REQUEST FOR EXTENSION OF
TIME TO FILE REBUTTAL TESTIMONY**

Verizon California, Inc., Verizon Long Distance, LLC, Verizon Enterprise Solutions, LLC, Frontier Communications Corporation, New Communications of the Southwest Inc. and New Communications Online and Long Distance, Inc. (collectively, "Applicants") respectfully request that the Administrative Law Judge extend the deadline for Applicants to file Rebuttal Testimony to October 5, 2009. As set forth in the Procedural Order dated September 16, 2009, the deadline for Staff's Testimony was extended to September 21, 2009. Staff indicated in its September 15, 2009 Motion that it would agree to an extension of time for Applicants and that there was no need for a change

1 in the hearing date. After reviewing Staff's Testimony and given demands in other states,
2 Applicants believe that an extension until October 5, 2009 is appropriate. Applicants do
3 not believe that any further extensions of this deadline or other deadlines, including the
4 hearing date, will be necessary. The Applicants have discussed this request with Staff, and
5 Staff has agreed to this extension.

6 For these reasons, Applicants request an extension of the deadline for their Rebuttal
7 Testimony until October 5, 2009.


