**STAFF'S MOTION FOR ENTRY OF  
ORDER NUNC PRO TUNC CORRECTING  
DECISION NO. 71259**

The Arizona Corporation Commission Utilities Division Staff ("Staff") hereby requests that Decision No. 71259 be amended to reflect Staff's position as stated in the staff report in this matter. The staff report in this matter states: "Staff typically recommends that equity represent not less than 30 percent for *cooperatives* to provide a balance of cost and financial risk." (Staff Report at page 4) (emphasis added). Decision 71259 states at paragraph 25 on pages 4-5: "Staff typically recommends a company capital structure consisting of a minimum of 30 percent equity of total capital as appropriate to provide a balance of cost and financial risk for regulated utilities and ratepayers."

Staff respectfully requests entry of order *Nunc Pro Tunc* to correct Decision No. 71259 by deleting the word "company" on page 4 line 25 and inserting the words "for cooperatives" after the word "structure" on page 4 line 25. As requested by Staff, paragraph 25 of Decision No. 71259 would read: "Staff typically recommends a capital structure for cooperatives consisting of a minimum of 30 percent equity of total capital as appropriate to provide a balance of cost and financial risk for regulated utilities and ratepayers."
