

**RUCO'S REQUEST TO CONTINUE
HEARING FOR ONE WEEK**

The RESIDENTIAL UTILITY CONSUMER OFFICE ("RUCO") through undersigned
counsel hereby requests to continue the hearing scheduled for January 4, 2010 for one
week. The undersigned counsel requests this continuance to accommodate previously
scheduled holiday plans. Because the undersigned will be out of state between December
19, 2009 and January 3, 2010, there is inadequate time to review rejoinder testimony

1 scheduled to be filed on December 28, 2009 and otherwise properly prepare for hearing.
2 The Staff has no objection to a one-week delay in the hearing. As long as rescheduling
3 the matter to commence January 11, 2010 will not alter the time clock and extend the date
4 of decision, LPSCO will agree to the hearing being rescheduled. LPSCO notes this may
5 require the parties to brief the case one week faster than would otherwise be the case. If
6 the hearing is going to be continued one week, then LPSCO would also like the deadline
7 for rejoinder and the pre-hearing conference moved to January 4, 2010 or after. RUCO
8 proposes a rejoinder deadline of January 4, 2010 and a pre-trial conference on January 8,
9 2010.


